

LIMITED WARRANTY

HAMLEY WELLS CORPORATION (JANE HAMLEY WELLS)

Jane Hamley Wells warrants its products to be free from manufacturing defects for a period of two (2) years from date of original purchase. Jane Hamley Wells, as its sole obligation, will repair or replace (at its option) any product, part, or component covered by this warranty, which fails under normal use as a result of a defect in material or workmanship. Jane Hamley Wells will repair or replace the aforementioned product, part, or component with a comparable product, part, or component. This warranty extends only to the original purchaser who acquires the product new from Jane Hamley Wells, its affiliate(s), or its authorized reseller(s), if any. Any product, part, or component must have been installed, used and maintained in accordance with the written instruction of Jane Hamley Wells, if any, included with the product or otherwise provided to purchaser. This warranty covers defects in materials and manufacturing only; it does not include normal wear and tear, misuse or abuse of product, or damage caused by lack of proper care and maintenance. Any modification to the original product voids this warranty.

JANE HAMLEY WELLS DOES NOT WARRANT AGAINST:

- natural variations in the surface grain or texture, or the presence of character marks in, wood, leather, stone or other natural materials
- changes in the surface finish due to aging or exposure to light
- any damage or failure caused by outdoor use of a product not specifically designed and sold for outdoor use
- any damage or failure resulting from improper storage or exposure to extreme temperature or humidity
- failure resulting from normal wear and tear
- the matching of colors, grains, or textures in natural materials
- the colorfastness or the matching of colors of textiles, including an exact match to samples or swatches
- irregularity in the register of printed textiles
- damage from sharp objects or imprinting from writing instruments

Jane Hamley Wells tests Customer's Own Material (COM)/ Customer's Own Leather (COL) only for the ability to manufacture with such materials and does not provide any warranty with regard to these materials.

TO THE EXTENT PERMITTED BY LAW, ANY IMPLIED WARRANTIES, INCLUDING BUT NOT LIMITED TO, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE HEREBY DISCLAIMED AND TO THE EXTENT THEY ARE LEGALLY REQUIRED, ARE LIMITED IN DURATION TO THE DURATION OF THIS LIMITED WARRANTY. TO THE EXTENT PERMITTED BY LAW, JANE HAMLEY WELLS SHALL NOT BE LIABLE FOR ANY INCONVENIENCE, COMMERCIAL LOSS, OR INCIDENTAL OR CONSEQUENTIAL DAMAGES. REPAIR OR REPLACEMENT OF THE PRODUCT UNDER THIS LIMITED WARRANTY IS THE PURCHASER'S EXCLUSIVE REMEDY.
